MEANS OF CONTROL

1.To control the quality of raw materials follow the methods below:

We asked our suppliers to test their upper leather for Cr VI, PH and DMFu by themselves; asked lining suppliers to check tear strength, especially abrasion resistance; and the suppliers for toecaps and insert need to test impact/compression and penetration resistance for their components...after all raw material can reach relevant requirement, we will accept them and use in mass production.

2. During development, we will take some samples to check the main physical properties, such as impact, compression, slip resistance and so forth, in order that we can control the quality from development and will avoid some additional troubles in the following steps; if the result can meet requirement, we will process forward; otherwise we need pay more attention to development for the better shoes;

3. We control the whole procedure from cutting to package. Every step, relevant QC will check the quality, the semi-finished goods and finished shoes will be discarded if cannot reach requirement of quality. Of course we take some samples from line to test bond strength, impact ect to confirm the mass production are under control. Finally, before shipment, the QC will perform the final inspection randomly, the shoes will be delivered in case the result is acceptable.

4.When do bulk the production each batch, we shall pick up some shoes from producing site randomly to test impact, compression, penetration, leather CR VI.... to control the quality to match the requirment of standard EN ISO 20345:2011.”

PPE subject to ageing :

Peremption period : 3 years when stored in appropriate conditions (humidity, temperature, clean , ventilated, light). Before use, the footwear shall be visually controlled, in case of deterioration the footwear must be scrapped (abrasion, cut, tear, ...).
